TERMS AND CONDITIONS

Government of India has received a credit from the International Development Association (IDA) and a Grant from the Department for International Development (DFID) in various currencies towards the cost of the AIDS prevention Project and intends to apply a part of the proceeds of this credit to eligible payments under the contract for which this invitation for quotations is issued.

1. Bid Price:

- a) The tender shall be for the full quantity of all item(s) as described in the schedule of requirement as mentioned at **Annexure-I**. The format of bid specified in **Annexure-II**, which should be used at the time of submission of the tender. The detailed specifications are specified in **Annexure-III**. Corrections, if any, shall be made by crossing out, initialing, dating and rewriting.
- b) The bid price shall include the excise duty and the bidder's cost towards insurance, packing & forwarding, transportation, Installation and delivery to the sites as per the consignee list at **Annexure- IV** as per the allocation indicated.
- c) Sales tax/VAT and any other local taxes should be clearly mentioned separately in terms of percentage and amount.
- d) Conditional price shall not be taken into consideration.

2. Bid Security & documents:

- a) The bidders shall furnish Earnest Money Deposit (EMD) amounting to Rs. 50,000.00 in shape of crossed Demand Draft/Pay Order in favour of "Orissa State AIDS Control Society", payable at Bhubaneswar, drawn from any scheduled banks. Any bid not secured with EMD will be rejected. The above EMD will be forfeited if a bidder (i) withdraws its bid during the period of bid validity or (ii) fails to perform the contractual obligations as per the purchase order.
- b) Each bidder shall submit only one quotation. Alternative offer without separate bid security will be rejected.
- c) The bidder shall furnish valid photocopies of VAT/CST registration certificate and photocopies of up-to-date VAT/CST clearance certificate in the bid.

- d) The bidder shall furnish documents like technical brochures, leaflets etc. establishing the eligibility and confirmation of the goods offered to the technical specifications and standards of the goods for all the items in the package quoted for if any.
- e) The goods offered by the bidder must meet the required technical specification and confirm to the standards if any, mentioned in the technical specifications. And both the Items i.e. LCD Television & DVD player must be from one make/brand.
- f) The bidder (in case he is not the manufacturer) must submit the manufacturer's authorization letter for TV sets & DVD players (A manufacturer can authorize only one bidder to quote for a particular product for OSACS as per format specified at **Annexure-V**).

3. **Eligibility Criteria:**

- a) Full quantity of all items as described in the package
- b) Required EMD.
- c) Up-to-date VAT/CST Clearance Certificate.
- d) Manufacturer's authorization as per format in case of dealer/distributor.
- e) Bid price as per format as specified in **Annexure-II**.
- f) Technical Boucher/leaflets of the product offered.
- i) Any other document as mentioned in the tender.

- 4. **Validity of Tender:** The tender shall remain valid for a period **not less than 90 days** after the last date as specified in the tender. (a) Notwithstanding the above, the Purchaser reserves the right to accept or reject any bid and to cancel the bidding process or reject all bids at any time prior to the issue of Purchase Order.
- 5. Total package price will be taken in to consideration while evaluating the bids and accordingly order will be placed to the lowest evaluated package price.
- 6. Purchase order will be placed to the bidder whose bid is selected by the Purchaser prior to expiry of the bid validity period. The terms of the accepted offer shall be incorporated in the purchase order.
- 7. The purchaser reserves the right at the time of placement of purchase order to increase or decrease the required quantity by up to 20%.
- 8. The delivery and installation should be completed **within 30 days** from the date of receipt of the confirmed purchase order as per the consignee list. The purchaser shall have the right to inspect the goods prior to dispatch at manufacturer's/supplier's premises or after delivery at consignee place before release of payment.

9. Any delay by the supplier in the delivery of the goods shall render the supplier liable to be charged liquidated damages @ 0.5% per week or part thereof subject to a maximum of 10% of purchase order value which will be deducted from the payment due.
10. Payment will be made after receipt of the proof of delivery along with satisfactory functioning of the items from the respective consignee list.
11. The supplier will provide **on-site guarantee/warranty for a period of 12 months from the date of installation in the consignee places** and during this Guarantee/warranty period, if any defects are noticed, the supplier shall replace/repair the defective items **within 10 days** from the date of receipt of the complaint on free of cost.
12. The tenders are liable to be rejected if any of the above conditions are not complied with.
- 13. Issue of Purchase Order:**

Purchase Order will be placed to the selected bidder whose bid has been determined to be substantially responsive and who has offered the lowest evaluated bid price. Only package price (i.e. including TV & DVD player) shall be taken into consideration, not item wise price.
14. Any effort by a bidder to influence the purchaser in taking decision on bid evaluation or placement of purchase order may result in rejection of the bidder's offer.
15. Any legal disputes arising out of this are subject to Bhubaneswar jurisdiction only.
16. Bidders may be present in person or through their representative(s) during the opening of tenders at **16.00 hours on 20/12/2011**.
